Archbishop Ezekiel Kondo led the Retreat and began with a question:

The message of the Gospel arrived with the eunuch minister, and the evidence for that is the Christian kingdoms in the land of Nubia in northern Sudan, whose traces still remain, with the presence of some customs in the current region that trace their origins back to


Christianity in the region. Anglican Tradition and system of worship were emphasized.


tion of the Episcopal Church of Sudan for the year 2019, and after discussion the meeting came out with the following decisions:

- Approval of the position of Assistant Bishop for the Dio-


Seminar for priests and laity



A new government was formed in Sudan, in implementation of the peace agreement signed between the government and the armed opposition movements in Juba, the capital of southern Sudan, last year, and the formation of the Legislative Council is still suspended until now.
